SUMMARY OF THE POSITION

Person at an outpost or dispensary in a locality covered by the provisions on regional disparities, who, in addition to his regular duties as a nurse, does patient assessments that allow a doctor to make a diagnosis at a distance and determine the appropriate interventions. Also is required to carry out actions and interventions that are generally reserved to doctors in other work environments.

SPECIFIC FUNCTIONS

Awash services support pregnant mothers, young children and their families. This includes providing preventive services such as pre & postnatal care, well-baby checkups, immunization & breastfeeding support, but also long-term follow up and support services for families with children with special needs or psychosocial difficulties.

The Uschiniichisuu life cycle service components aim at providing health and social services for prevention, care, rehabilitation and support of children and youth 10-29 years old and their families. The goals of the Uschiniichisuu services is to help foster health and well-being in Eeyou youth by addressing their security and developmental needs as well as developing their strengths in order to meet the challenges of going through the transitional period towards adulthood. The Awash and Uschiniichisuu nurse works in a multidisciplinary approach.

REQUIREMENTS

- Three (3) years of experience as a nurse including:
 - One (1) year of experience in critical care **or**
 - Two (2) years of experience at the CBHSSJB

Language:

- Fluent in English;
